

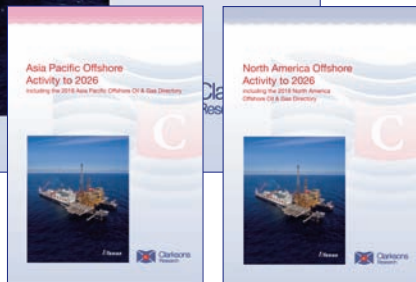
# The Offshore Regional Directory Series 2018
